<sup>1</sup> Annotated copy of plan required if advice on reinstatement is requested. This copy should show information relating to the reinstatement methodology, origin of survey marks or other information that would assist in the assessment of the survey and the plan.

<sup>2</sup> A Survey Report may be omitted if the annotated copy of the plan fully explains the survey, or if advice on reinstatement is not required. However, a survey report, in the form of survey records, must be provided for ambulatory boundaries.

<sup>3</sup> Original Survey Records must be deposited if all of the survey information is not shown on the face of the plan (e.g. traverses of watercourse boundaries, etc.).

<sup>4</sup> Where new permanent marks have been placed or existing permanent mark sketch plans have been updated these sketches must be provided.
